

- Currently, nearly all medicines information is in paper format and too complex
- Why is this challenging?



Access & Understanding → why is this challenging



Firstly, the text may be printed in very small sizes, may not be easy to understand, and may not be up to date.

It is extra work for patients that are aging, and/ or living with chronic diseases and multiple conditions, that need several treatments at the same time and read multiple paper leaflets for different medicines.

Gravitate-Health hopes that by making information on medicines **more accessible and understandable**, patients will be more likely to take their medicines correctly, resulting in better health outcomes and quality of life.
