The Gravitate-Health digital platform uses trusted information in a focused way—via the G-lens[®] services— from electronic product information (ePI, i.e. medicinal product leaflet in an electronic format) and a subset of health record data (IPS). The platform presents users only with information that is relevant to them, based on their conditions and preferences. Additional trusted materials can be incorporated for safety and to enhance understanding. The G-lens[®] services consider your medication list, allergies, conditions, therapy plan, health goals, personality, lifestyle, etc.



A digital platform with G-lens® services will enable citizen empowerment and engagement to stimulate adherence to treatment, safety, and improved quality of life.
